

# LIMITED WARRANTY

**Effective Date: September 10, 2008**

Reference: AD195-20080910

Ballard Technology, Inc. (the "Manufacturer") warrants its hardware products to be free from defects in materials and workmanship under normal use for the periods listed below. This limited warranty does not cover products damaged by accident, disaster, misuse, abuse, or unauthorized modifications. Opening the case of a sealed product voids this warranty.

**Commercial grade hardware interfaces:** 3 year limited warranty when used in a controlled environment equivalent to an office or laboratory. Damage caused to commercial grade products by their use in a rugged or extended temperature environment is not covered by this warranty.

**Rugged or extended temperature grade hardware interfaces:** 1 year limited warranty.

**Handheld testers:** 1 year limited warranty.

**Cables and other accessories:** 90 day limited warranty.

Manufacturer warrants its software products to perform substantially in accordance with their accompanying written materials for a period of ninety (90) days from delivery.

The warranty for third party products resold by Manufacturer is limited to the warranty provided by the third party.

## CUSTOMER REMEDIES

Should the product fail to be in good working order during the warranty period, the Manufacturer's sole obligation shall be at its option, to repair, correct or replace the product, or, at Manufacturer's sole discretion, to refund amounts paid for such product upon its return to a location designated by Manufacturer in the United States. Manufacturer shall pay for the return of the product to the Customer to a location within the United States. Customer shall be responsible for paying all shipping charges, duties, taxes, and any other charges for products returned to any other locations.
